IN FY25, WE REACHED 6,233 INDIVIDUALS, REFLECTING A 9.9% INCREASE IN PEOPLE SERVED OVER LAST YEAR. WITH DONOR SUPPORT, 1,211 STUDENTS RECEIVED 1-ON-1 COUNSELING, 5,741 STUDENTS PARTICIPATED IN OUR SCHOOL-BASED "TALK" PROGRAMS, AND 3,129 STUDENTS ENGAGED IN SAFETALK PREVENTION PROGRAMMING.
